Foreword

This document is a transcription of the records of the *Eureka Congregational Church*, later known as the *Hurdsfield Congregational Church*, Hurdsfield, ND. It is recorded in a *Pilgrim Church Register Record* book, published by the Pilgrim Press of Boston and Chicago, "...as a practical way of keeping a parish register." The book apparently was obtained and used throughout the life of the church until it was closed and sold. Eventual disposition of this book is to be determined as this transcription is being prepared, although it is intended that it will be preserved in an appropriate museum or library.

Early in the church history there were four distinct communities served by this church:

<u>Eureka</u>: no records found. Land description matches Eureka school, 2 miles west and 5 miles south of Hurdsfield, Eureka Township, Wells Co. ND, NE corner Sect 21-145-73.

Hurdsfield: town in ND, site of the church building.

Lamoine: no records found.

<u>Bostonia</u>: This was a farm post office established February 8, 1908 with Theodore A. Stramblad as Postmaster at his home in the southeast quarter of section 30-144-73, Stewart Township eight miles north of Tuttle.

A major reason for undertaking this transcription was to capture the text of the document in digital form to facilitate wider distribution. Another reason was to permit computer searches and analyses of the text. An attempt was made to preserve the form of the document. The text was copied as originally spelled, punctuated and formatted, although the reader will doubtless be able to find inconsistencies in how rigorously that was achieved.

Annotations

All added text is marked by enclosing insertions in square brackets [...] to note page numbers in the register and to provide descriptive notes not explicitly included in the original.

Pages of this transcript are numbered at the bottom. Bracketed page numbers at the right margin in this transcript identify the location of source material in the *Register and Record* book.

Eureka Township, Wells Co. N. Dak. Aug. 1903

The settlement up to the year 192 had been very meager but during the spring and summer the people settled here rapidly. The settlers represented an energetic and Christian spirit. A desire now became manifest that we meet in Christian fellowship. Accordingly the people met at the D. E. Hurd home, and plans were talked over. It was decided to meet each Sabbath afternoon at the several homes for prayer and song services. In due time we saw the need of purchasing lesson helps and appointing a leader to superintend the work. In this we were generously helped both spiritually and financially.

As winter approached a problem confronted us, must we discontinue our meetings?

Every Home circle has his or her place, a light that lighteth and so our little Sunday School found shelter during the winter of 1902 and 1903 at the home of Mr. and Mrs. Bowers. The memories of that winter will ever be cherished with peculiar interest. In the spring of 1903 a school house was built, so accordingly on the 5th of April the Eureka Union Sunday School was organized and officers were elected. At the same meeting Rev. Stickney of Fargo met and encouraged the people to unite as a church.

Recognizing the needs and desires of this people Rev. Van Arsdale was sent to propond the word of truth and love to our people and through his wise and untiring efforts the First Congregational Church of Eureka was organized

The people here, wish to record their appreciation and gratitude for the service rendered and do express our hopes that God may richly bless every work in his name & rejoice "That the whole round earth is everywhere, bound by gold chains about the feet of God."

The following statement was submitted by the people of Eureka

We, whose names are hereby subscribed, beliving in the Bible as the Divine revelation, in Jesus Christ as our Savior, and desiring to be united as a Church of Christ and further believing that a church organized on Congregational principles is practicable those living in the vicinity of the Eureka School house, agree to become members of such a church as soon as it can be organized.

By-Laws.

Art I

Name.

This Church shall be called the First Congregational Church of Eureka

Art II

Covenant

The covenant by which this church exists as a district body, and which every member accepts is as follows.-

Acknowledging Jesus Christ to be our Savior an Lord, and accepting the Holy Scripture as our rule of faith and practice, and recognizing the privilege and duty of uniting ourselves for Christian fellowship, the enjoyment of Christian ordinances, the public worship of God, and the advancement of his kingdom in the world, we do now, in the sight of God and invoking his blessing solemnly covenant and agree with each other to associate ourselves to be a church of the Lord Jesus Christ as warranted by the Word of God.

We agree to maintain the institutions of the Gospel, to submit ourselves to the orderly administration of the affairs of the Church, and to walk together in brotherly love.

And this we do depending upon the aid of our Heavenly Father, who so loved the world that he gave his only begotten Son for our salvation, and Jesus Christ who hath redeemed us with his blood and of the Holy Spirit our Comforter and Guide.

Art III

Charter

Sect I. Policy. Its government is vested in the body of believers who compose it. It is subject to the control of no other ecclesiastical body, but it recognizes and sustains the obligations of mutual counsel and cooperation which are common among Congregational churches, and it is in fellowship with all churches which acknowledge Jesus Christ to be their divine Redeemer and Lord.

Sect II Doctrine. It receives the Scriptures as its authority in matters of Faith and practice. Its understanding of Christian Truth as contained therein is in accord with the belief of the congregational churches of the U. S. and substantially as set forth by unanimous vote of the National council of 1865 (?) or by the National Council's commission in 1883 in the form authorized to be printed in this manual.

Art IV

Membership

Sect I. Qualifications

Its membership consists of such persons as confess Jesus Christ to be their Savior and Lord, and who, (1) after due examination, either by the Church committee or by the church itself, as to their Christain experience, and, if coming from other churches, as to their letters of admission and recommedation or satisfactory substitutes therefor, and (2) after proposal from the pulpit on some Lord's Day prior to that of their reception, (3) having been baptized accepted by vote and " " " " " (having been baptized ??), (4) enter into Covenant and subscribed to its By-laws, and are formally received into it fellowship.

Sect II Reception

The reception of members shall ordinarily be upon some Lord's Day when the Lord's Supper is administered, and shall be in the form appended to these By -laws.

Sect III Duties

Members are expected, first of all, to be faithful in all the spiritual duties essential to the Christian Life; and also to attend habitually to the services of this Church, to give regularly for its support and its charities, and to share in its organized word.

Sect IV Rights

Such members as are in full and regular standing, and do not hold letters of dismission, and recommendation may act and vote in the transactions of the church.

Sect V Termination

The continuance of membership shall be subject to the principles, and usuages of the Congregational churches, and especially as follows:-

- (1) Any member in good and regular standing who desires a letter of dismission and recommendation to any other evangelical church is entitled to receive it upon his written request. In case of removal to anther community he should promptly make such request. This letter shall be valid as a recommendation for only one year from its date, unless renewed, and this restriction shall be stated in the letter.
- (2) If a member desires to join a religious body with which this Church is not in Fellowship, or which would not receive its letter, the Church may, at his request, give him a certificate of his good standing and terminate his membership.
- (3) If a member in good standing request to be released from his covenant obligations to this Church for reasons which the Church may finally deem satisfactory, after it shall have patiently and kindly endeavored to secure his continuance in its fellowship, such request may be granted and his membership terminated.
- (4) The Church may also, after due notice and hearing and kindly effort to make such action unnecessary, terminate the membership of persons for the space of two years non-resident, or for the same space of time not habitually worshiping with the Church.
- (5) Should a member become an offence to the Church and to its good name By reason of immoral or unchristian conduct, or by persistent breach of his covenant vows, the Church may terminate his membership, but only after de notice and hearing, and after Faithful efforts having been made to bring such members to repentance and amendment.
- (6) The membership of no person shall be terminated except by letter, at the meeting when the recommendation for such action is made.

Sect VI Restoration

Any person whose membership has been terminated may be restored by vote of the Church, if for any offence, upon evidence of his repentance and reformation, or if on account of continued absence, upon satisfactory explanation.

Art. V Officers and Committee.

Sect. I. The Officers and Committee shall be as follows:-

- (1) A pastor to be chosen and called by the Church whenever a vacancy occurs, and to be installed by Council when the Church and Pastor shall so agree.
- (2) a clerk to be chosen at each annual meeting to serve for one year and until his successor shall be chosen, and qualified.
- (3) Two Deacons, one of whom shall be chosen each annual meeting to serve for a number of years equal to the number of deacons.
- (4) A Treasurer to be chosen at each annual meeting to serve for one year and until another shall be chosen in his stead.
- (5) A Church Committee to act with regard to the spiritual conserns of the Church, which shall consist of the above-named officers, Or.

A Prudential Committee, which shall consist of three or more as may be determined at the time, to have charge, under the direction of the Church, of its financial and business affairs, to be chosen at each annual meeting, and to serve for one year.

- (6) All the officers and committee named in the above sections shall be elected by ballot, and all elections shall be determined by a majority of the votes cast by the members present who are qualified to vote.
- (7) The Church may also choose a Music Committee and such other Committees as it may deem advisable.
- Sect. II. The Pastor shall have in charge the spiritual welfare of the congregation; he shall preach the Word and have in his care the stated services of public worship, and shall administer the sacraments. He shall preside at all meetings of the Church, except as limited in Art VIII.
- Sect. III. The Church shall keep a compete record of the transactions at all business meetings of the Church, which shall be read for approval at the next-following special business meetings and also of the Church Committee and the Prudential Committee, or of the Board of Trustees if either of these bodies shall be chosen.

He shall secure the signatures of members to the By-laws, and keep a register of their names with dates of admission and dismission or death, together with a record of baptisms. He shall also notify all officers, members of committees and delegates of their election or appointment. He shall issue letters of dismission and recommendation voted by the Church, preserve on file all communications and written official reports, and give legal notice of all meetings where such notice is necessary, as indicated in the By-laws. The Clerk shall be sworn if required by the State.

Sect. IV. The Deacons shall provide for the Lord's Supper and aid in its administration and shall care for the poor, call upon the Treasurer by vote as a board, at their discretion for any Funds in his possession held for these purposes.

Sect. V. The Church Committee shall examine and propound candidates for admission to the Church, shall provide for the supply of the pulpit in any vacation of the Pastor, shall decide on objects for regular or special collections when the church has not acted thereon, shall have regard to discipline a provide in the articles relating to that subject, and shall be watchful for the spiritual interests of the church. It shall make a written report at each annual meeting of the matters under its charge.

Sect. VI. The Treasurer shall keep separate accounts as follows.

- (a.) Of all moneys contributed at the Lord's Supper which shall be primarily devoted to the relief of the poor, and which contributions, together with all other moneys given for that purpose, he shall hold subject to the order of the Board of Deacons.
- (b.) Of all moneys raised for the object of Christian benevolence, to be paid by him to the several persons or societies entitled thereto.
- (c.) Of all moneys received by him for the support of public worship or of any department of Church work, to be paid out on order of the Church or of any persons or committees authorized by the Church therefor.

All the treasurer's accounts shall be kept distinct from all other accounts and all deposits made, and all checks drawn by him shall be in the name of the Church.

He shall make an annual writen report in detail of his receipts and expenditures, properly audited by some person previously appointed by the church.

Art. VI Property and Finances

The Trustees or Prudential Committee shall have the actual care of the place of worship, but shall have no power to buy, sell, mortgage, lease or transfer any property without a special vote of the Church authorizing such action. They shall provide under the direction of the church, for the raising of money for the support of its public services, shall have general charge of its Finances other than moneys contributed at the Lord's Supper or for any charitable or benevolent objects, shall authorize and direct Treasurer as to the payment of moneys under their control, shall provide for the proper auditing of his accounts unless the church shall appoint an auditor, and may, at their discretion, call meetings of the church for matters with which they are concerned. They shall make at the annual meeting a detailed report in writing of all their transactions during the year.

Art. VII Organizations

The Church regards as integral parts of itself all organizations formed for the purposes of ministration and which use the facilities of the Church property. Of all such organizations the Pastor shall have general oversight; and the church will expect a report from each at its annual meeting.

Art. VIII Meetings

- **Sect.** I For worship (1) Public services shall be held statedly on the Lord's Day and on some regular evening of each week, whenever it is deemed expedient.
 - (2) The Lord's Supper shall be celebrated at such regular dates as the Church may, from time to time determine: and unless otherwise ordered, upon the First Lord's Day of each alternate month beginning with January.
 - (3) Occasional religious meetings may be appointed by the Pastor at his discretion or by vote of the Church.
- Sect II For business (1) At any of the regular meetings for worship the Church may, without special notice act upon the reception of members previously propounded or upon the dismissal of members to other churches, and upon the appointment of delegates to councils and conferences of churches, but not upon other business.
 - (2.) The Pastor may, and shall when requested by the Church Committee, call from the pulpit special business meetings, the particular object of the meeting being clearly stated in the notice. Special meetings of the Church shall also be called by the Clerk upon the written applications of any five adult members specifying the object thereof, which notice shall be read at the public service on the Lord's Day next preceding the day fixed for such meeting. No special meeting shall be held on the same day on which the notice is given.
 - (3.) The annual meeting of the Church shall be held on the first Tuesday in April, at which time the annual reports shall be presented and officers elected, and such other business transacted as may be specified in the call or authorized in the By-Laws. This meeting shall be called by the Clerk in the manner specified in the paragraph preceding.
 - (4) At all meetings for business called by the clerk a chairman shall be chosen by vote of the Church; but at all other meetings the Pastor shall preside, except that in his absence or when the business relates to himself, the Church shall elect a chairman.
 - (5) At the annual and all special meetings one third of residence members shall be necessary to constitute a quorum for the transaction of business.

Art. IX Discipline

- **Sect I** Should any unhappy differences arise between members, the aggrieved member shall follow in a tender spirit, the rules given by our Lord in the eighteenth chapter of the Gospel of Matthew.
- **Sect II** Should any case of gross breach of covanant or of public scandal, occur, the Church Committee shall endeavor to remove the offence, and if such effort fail shall report the case to the church.
- Sect III If the Church vote to entertain a complaint which must be made in writing, it shall appoint a reasonable time and place of hearing and notify the person in question thereof, furnishing him with a copy of the charges.

- Sect. IV At such hearing the accused member may call to his aid any member of the Church as counsel. If he shall not present himself at the time appointed or give satisfactory reasons for his neglect so to do, the Church may proceed in his absence.
- Sect V. All such proceedings should be pervaded by a spirit of Christian kindness and forbearance, but should an adverse decision be reached, the Church may proceed to admonish or to declare the offender to be no longer in the membership of the Church.
- Sect VI. In case of grave difficulty the Church will be ready, if required, to ask advice of a mutual council.
- Sect VII If desired letters of members coming from other churches may be keep on file and will be affectionately delivered and recommended when required.

Art. X Amendments

These By-Laws may be amended by a three-fourth vote of the members present and voting at any annual meeting of the Church or at a meeting specialy called for that purpose, the proposed amendment being inserted in the call, but no charge shall be made in Articles II and III, entitled, "Covanant" Character, except at an annual meeting and by a three-fourth vote of all the members of the church entitled to vote, said proposed change having been laid before the Church in writing at a business meeting not less than one month before the time of the proposed action and read from the pulpit on the Lord's Day next succeeding such proposal

Amendments to Constitution

[Pp 88, 89]

Article 1 Name and Preliminary Statement.

This church shall be called the Eureka Cong. Church of Hurdsfield and vicinity.

Its field of membership shall include all the regions about Hurdsfield, to maintain Sunday schools and preaching services.

It is understood alto that whenever in the judgement of a majority of the members in any neighborhood a separate church should be organized this may be done with the good will and cooporation of this church.

Article IV

(3) Any member of an evangelical church, who for any reason does not wish to leave his own church, may be voted into associate membership in this church and shall be entitled to all the rights and priviledges of full membership, excepting to vote on questions pertaining to the disposition of church property.

This relationship may be terminated on request, or upon removal from the community, or for cause, by vote of the church, and a letter may be given stating the relationship (sustained??)

Article IV

Sec (4) This section shall be amended by adding ehe following

"Provided that associate members shall be accorded the right to vote on all matters excepting the questions pertaining to the disposition of church property(".)

Article V

Sec. 7A board of trustees of nine (9) one third 1/3 of whom shall be elected at each annual meeting

These trustees shall as far as possible be so distributed that at least one (1) shall be chosen in each neighborhood, where a preaching service shall be held.

There may also be a finance or executive committee chosen to look after the work in each place where a Sunday school or preaching service is sustained. These shall work in cooperation with the trustees of the church.

The "(?) or trustees in any neighborhood shall ex officio be on this committee.

Amendment to this form for the reception of members to be used just before the "Benediction."

We recognize you as a member of a sister Evangelical church and as an associate member of this church, because we believe you are a follower of Jesus Christ as you divine Lord and Master. We expect you will live in substantial accord with the covenant of this church.

We welcome you heartily to our Christian fellowship and service. (")

Benshoof and Mrs. Bascom, for the Bostonia Ladies Aid Society by Mrs. Carlson, for the Sunday School in the Peak neighborhood by Mrs. Canning. The election of officers followed. G. S. Bascom was chosen Clerk, H. F. Miller Treasurer for Hurdsfield, Otis Shirk Treas. for Eureka, Mr. Frank Brolin Treas. for Bostonia, and E. E. Russ Treas. for Lamoine. Trustees were chosen, H. F. Miller for Hurdsfield, Chas. Benshoof for Eureka, Carlo Liesman for Bostonia, and E. H Hurd for one year (Eureka). Sunday School Superintendents were elected, for Hurdsfield E. L. Bishop, for Eureka J. Shirk, for Bostonia A. c. Carlson, and for Lamoine E. E. Russ. Mr. Charles Benshoof was reelected Deacon for Eureka, and C. C. Whipple was chosen Deacon for one year to fill out the term of E.G. Weckerly deceased. G. S. Bascom was called to the chair. The Pastor, in answer to a question, stated that he would not ask any more salary than was received during the current year; but if the crop should be good the Church could do as it liked. Voted that the vacation taken in the winter be considered the Annual vacation. Moved and seconded that Rev. C. M Steele by Pastor for a third year at the same salary as in the second year, -\$500. from the field. Decided by ballot in the Affirmative. The Pastor was called and informed of the result. He responded briefly and, after a vote to adjourn, gave the Benediction.

"3No regular meeting of Church called in 1914. Mr. Hand's pastorate ceased April 1st, 1914, and we were without preaching a few Sundays. Dr Stickney called on us and it was arranged between a number of the church members and Rev. Emil Dietrich that he be called for the following year, commencing with July 1st, 1914, with a salary of $$600^{00}$, \$200 of which is furnished by the Congregational Home Missionary Society and $$400^{00}$ by the church membership.

Peace and Harmony seem to have been the uniting spirit that has dominated the church the past year, and we feel that this is largely due to the good work done by our Pastor.

The only disturbing feature of our church work as a whole, we think, is the debt of the church – still on the building. While the whole amount was pledged on or before the dedication, many of those pledges have not been paid.

Our subscriptions for Pastor's salary, we think will not be met, but the building pledges will need more active work on the membership to clear our building debt.

During the year a number of special services have been held, and on Easter day, five new members were taken into the church – Mr. & Mrs C. C. Whipple & Stella Whipple and Mr. & Mrs W. L. Lukken all by letter. Respectfully submitted,

Financial Statement – June 1st 1915

The undersigned did not take charge of the church finances until in September 1914 and not until sometime in November did I get a statement of what had been collected and applied on our Pastor's salary. On Nov 10th a check was written for $$14^{63}$ which paid in full to Oct 31st, 1914. and on the 29th of Nov. another check was tendered him in full for Nov. Not until Jan 23, was I able to pay him for Dec. and from then until the present time, we have been going behind, being a little over three month's in arrears on June 1st. with only $$13^{49}$ to apply on same.

Only subscriptions have been applied on the Pastor's salary, the loose collections being used for currant expenses, such as fuel, gasoline, kerosine, and janitor hire, a part of the latter being also borne by the Sunday School. Out of this fund has also been paid our tax per member $$7^{56}$ – this paying up back tax from two years which we were behind. Some long standing coal bills were also cleaned up this year out of this fund.

Our total loose collections since Sept 15, 1914, amount to \$37.97 \$54.50 and disbursements \$37.91, leaving \$16.89 cash balance on hand in this fund.

Mesdames Miller, Pearl, Whipple & Weckerly agreed to circulate the subscription list for Pastor's salary for 1917-18 Com. Sept 15,1917. Vote of thanks was tendered E. L. Bishop for services during past years.

At the same meeting an invitation was given Rev. Emil Dietrich to accept the pastorate of the church for a year beginning Nov. 1 - 1919.

The call was accepted by Rev. Dietrich and his work continued with the church at Hurdsfield from Nov. 1-1919 til about Sept. 1-1922 at which time his resignation was accepted.

So many members had moved away from our town and economic conditions were so bad that it was not deemed advisable at this time to extend a call to another minister.

However in May 1923, Rev. A. H. Crombie then serving the church at Harvey N. Dak. signified his willingness to hold one week night service each week at Hurdsfield.

Thurs. evening was chosen and from about May 15 to Nov. 15, Rev Crombie preached to very good-sized audiences each Thurs. evening with one or two exceptions when weather hindered.

As he came over by auto, necessitating auto hire, he received but very little for his work & his faithfulness in attendance.

In Sept. 1923, Rev. E. H. Stickney D. D. came up from Fargo and has been with us on an average of once a month the remainder of '23 & to the present date May 1924.

He has succeeded in reviving the work to such an extent that on May 4, eleven new members were added to the church. He plans to continue his visits here for some time longer and we are hoping this is the beginning of a New Day for the Cong. church of Hurdsfield.

Rev. Kirk is on the field at present as a supply, and we hope int the near future to be able to call a regular, resident minister to this pastorate.

Mr. Heimer of the Evang. Church of Chaseley was hired April 1925 to preach 1 year for us and we voted to give him $$25.^{00}$ per mo. The Ladies aid at the end of the year gave him \$50.

Our beloved sister Mrs. Retta H. Weckerly was called to her heavenly home April 26, 1926, after but a few days of sickness

The presented diplomas of graduation from Oberlin College with the class of /05 and the Oberlin Theol. Sem. With the class of 1909 were inspected and approved by the scribe.

Mr. Steele was called on for statement of belief and call to the ministry, and presented the same well-prepared and delivered in a very commendable spirit: a statement not over-long yet comprehensive. Supt. Stickney moved the acceptance of statement and that the council be by itself to decide upon fitness of candidate for ordination. Motion was carried after brief further examination.

Council retires at 8 o'clock, and votes unanimously to proceed with the ordination. The candidate with chairman and scribe are named a program committee and presented the program below, which is followed in the immediately succeeding ordination service.

To the Eureka Congregational Church, Hurdsfield N. D.

Dear Brethren: as I am no longer the Pastor of the Congregation, I send my report as Pastor and superintendent at Hurdsfield and Pastor at Eureka. I was elected Supt. Of S. School at Hurdsfield on Jan 1, 1912. I introduced several new features, one which as I was absent one Sunday was put aside – the card which had on one side "I am early" and on the other side "I am late". The next feature was to give an evening entertainment to all who were not tardy for one month. There were 14 who were not tardy during the month of February. The next feature was a Treasurer and Secretary for each class which was successful. The next was to call for Bibles. The record shows we commenced with three, and the last call last Sunday, 15 were presented. This I think the most important of the new things introduced while I was Superintendent.
